

## **NORTHERN INLAND CREDIT UNION MEMBER SURVEY DRAW | TERMS AND CONDITIONS**

1. Entry into the promotion is deemed acceptance of these terms and conditions.
2. The promoter is Northern Inland Credit Union Limited (Northern Inland) ABN 36 087 650 422, AFSL 235022 Australian Credit Licence 235022, of registered address 481 Peel Street (Phone 1300 656 581) (Promoter).

### **Promotion Period**

3. The promotion commences at 12.01am on 10 May 2018 and closes at 11.59pm on 31 May 2018 (Promotion Period).

### **Eligibility**
